

Cherokee County DUI Treatment Court

Cost: \$90/week. Probation fees are not included (\$54.00 per month).

Miscellaneous: Participants will be required to wear a SCRAM device or other electronic monitoring device at the onset of the program at their own expense. The average length of time to wear the device is 30-60 days but may be extended at the Team's discretion. Initial cost of Scram is covered by the program then added to account after completion.
